ASCC, in its sixth year of operation, serves over 1300 members of our community annually with free and low-cost art programming for all ages. We have a generous offer to receive the donation of the historic 1880 Schoolhouse and the surrounding gardens (0.81 acres) we use as our home base for exhibits, classes, and community outreach programs. **Receiving this historic structure as a donation will allow us to continue to serve our community for years to come.** The structure is restored and in excellent condition and is currently used by ASCC year-round.

**To provide this home for art in our community, ASCC must raise a \$20,000 Capital Fund** to ensure the historic site and surrounding landscape will be taken care of and well maintained.
